STUDY VISA & STATURORY APPROVALS

Students should obtain statutory clearances from Ministry of External Affairs (MEA) and Ministry of Education (MoE) before admission.

- > Programme duration is 2 years

RULES FOR ADMISSION OF INTERNATIONAL STUDENTS

- The students from abroad viz., Foreign Nationals / Overseas Citizens of India (OCI) / Children of Indian Workers in Gulf Countries / NRIs will be admitted into PGDM (ABM), MANAGE, Hyderabad subject to fulfilment of conditions of the programme.
- > There will be no written test for admission. However, interview of the short-listed candidates will be conducted for admission.
- > Medical Fitness Certificate and three recommendation letters from faculty / employers of the applicants need to be submitted.



TEACHING METHODOLOGIES

The programme is built around 43 coordinated core courses, which provide a robust foundation in key management disciplines through collaborative learning, industry experiences and focused engagement with businesses. RULES FOR ADMISSION OF FOREIGN STUDENTS

(Applicable for students taking admission from the Academic year 2024-25)

The following category of students from abroad viz Foreign Nationals will be admitted to National Institute of Agricultural Extension Management (MANAGE), Hyderabad subject to the fulfilment of the following requirements under its PG Programmes titled 'Post Graduate Diploma in Management (Agri-Business Management) – PGDM (ABM).

In the course – PGDM (ABM), a 15% of seats may be filled as supernumerary seats over and above the total approved intake. There will be no written test for admission. Only interview of the short-listed candidates will be taken for admission. However, candidates shall have to fulfil the eligibility conditions for admission as laid down for the postgraduate programme as given below.

A. ELIGIBILITY AND ACADEMIC QUALIFICATIONS

All foreign students should have passed the examination in the concerned subject and should fulfil the minimum eligibility criteria for admission as per the requirement of programme from a University/Board included in the list of Association of Indian Universities (AIU). In case the University/Board is not included in the said list, the candidate has to obtain and submit an equivalence certificate to this effect from AIU subject to its final verification by the respective Department. If the candidate has a non-Indian bachelor's degree not recognized by AIU/AICTE, he/she is required to produce proper certification from a national body in the country concerned, constituted for certifying equivalence of degrees. The eligibility for the programme is outlined below:

MINIMUM REQUIRED QUALIFICATION

A bachelor's degree in Agriculture & Allied Sectors with a minimum of 50% marks in aggregate in all subjects.

B. ADMISSION PROCEDURE

Applications from foreign nationals for admission to the PGDM (ABM) programme at the Institute, that are received through the website of 'Study in India' by June 15, 2024 for the session commencing in July 15, 2024 will be considered. The desirous foreign nationals will submit their complete curriculum vitae and credentials with regard to their academic qualifications indicating clearly the following details with all supporting documents:

- 1. Proof of 10+2 (Schooling and Pre-university studies)
- 2. Duration of the undergraduate programme/qualifying examination completed
- 3. Class obtained/Percentage of marks where marks are awarded
- 4. Cumulative Grade Point Average (CGPA) where grades are awarded
- 5. Transcripts of all the courses cleared in the undergraduate /qualifying examination (with explanation of assigned grades)
- 6. Proof of clearance from MHRD/MEA, Gol as applicable
- 7. Three recommendation letters either from faculty members who have taught the applicant earlier (at least two) or persons under whom the applicant may have worked (at most one)
- 8. Scanned copy of relevant passport pages showing nationality and personal details
- 9. Applicants are requested to attach a MEDICAL FITNESS CERTIFICATE from a doctor attesting to their physical and medical fitness
- 10. Two (2) passport size colour photographs

Those foreign nationals who passed their qualifying degree examination from any of the Indian Universities are also eligible to apply for admission in to PGDM (ABM) programme. The applications containing detailed information and particulars as stated above along with relevant supporting documents should be submitted to Principal Coordinator – PGDM (ABM), National Institute of Agricultural Extension Management (MANAGE), Rajendranagar, Hyderabad – 500 030, Telangana, India. The admission will be subject to clearance from the Ministry of Human Resource Development / Ministry of External Affairs, Govt. of India, New Delhi.



C. OFFER OF ADMISSION

Offer will be made based on recommendations of the Admission Committee at MANAGE. The students will be informed by email. Students applying through institutions / organizations having tie up with Govt. of India will be intimated through proper channel.

ADMISSION PROCEDURES FOR FOREIGN STUDENTS UNDER CULTURAL EXCHANGE FELLOWSHIP PROGRAMME. Gol

- Candidates seeking admission under a Cultural Exchange Fellowship programme are required to apply through the Indian High Commission/Embassy in their respective countries
- In case the applicant is found suitable for admission, the admission offer letter will be sent to the candidate through the Indian Council for Cultural Relations, New Delhi

D. VISA AND NO OBJECTION CERTIFICATE

Only persons with the purpose of studying in India and entering the country on STUDENT VISA shall be eligible to apply for admission in to a particular course. The candidates should submit a copy of their Passports and Visa to the Institute at the time of joining in the Institute. The student should also obtain a No Objection Certificate (NOC) from the Ministry of External Affairs, Government of India. F. PAYMENT OF TUITION FEES

 All selected foreign nationals for PG programme will be required to pay the prescribed tuition fees of US \$12000 for programme of 2 years including hostel accommodation and boarding charges, etc. However, this amount does not include costs of VISA, Travel, and Medical Insurance. Note 1: Student Health Insurance will have to borne by the students themselves. The insurance cover should be minimum of Rs.5 lakhs.

Note 2: Any other additional expenses to be borne by the individual.

Note 3: PGDM (ABM) programme of MANAGE is a self-financed programme. Hence, MANAGE does not provide any scholarships to foreign nationals. However, applicants are encouraged to apply for sponsorship from any authorized organizations.

2. The candidate will be required to pay the fees at the time of registration. The Cheque/Draft should be drawn in favour of MANAGE, Hyderabad and should be payable at Hyderabad (India). The fees once paid is not refundable. The candidate is required to ensure his/her eligibility, fitness and documentation support for his/her admission to avoid any future inconvenience.
